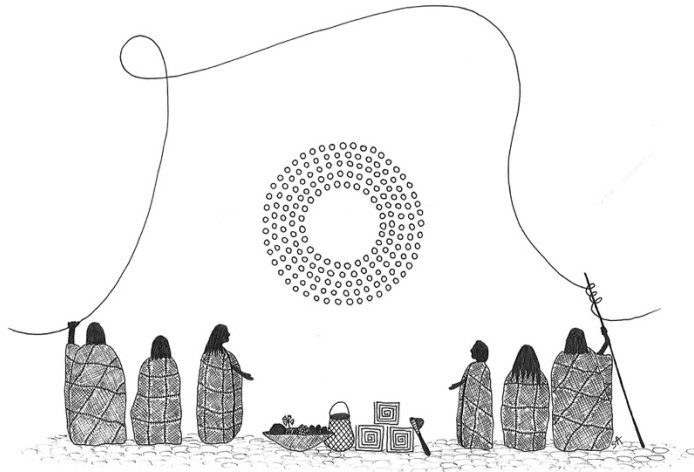

PARENTAL CONSENT FORM

Privacy Collection notice:

We will only retain your personal information for as long as required for the purpose for which it was collected and in accordance with our legislative obligations. This information will then be securely destroyed in accordance with the [University's retention and disposal authority](#).
